In the examination to date the Inspectors have had regard to the representations made concerning the Duty to Cooperate, addressed this through their MIQs and discussed this during the hearings. Whilst the Duty to Cooperate is to be abolished, national policy for maintaining effective cooperation such as that set out in the National Planning Policy Framework (September 2023) in paragraphs 24-27 remain, and this continues to be a matter for their assessment of soundness.
