

Wiltshire Local Plan Review - Examination in Public

Further Note on Policy Supersession 12 December 2025

- 1.1. As requested by the Inspectors when discussing policy supersession under Matter 1
 Procedural, legal and other requirements (continued) on 11 13 November 2025, this Note
 sets out the approach to the supersession of policies in the adopted development plan by
 the Wiltshire Local Plan Review, whether any modifications may be required in this regard,
 and any associated issues and explanation.
- 1.2. This follows the council's 'Note on the Law Concerning the Supersession of Policies' (EXAM 5), which set out the legislative context on this matter and the council's view that, as a matter of principle, Regulation 8(5) of the 2012 Regulations¹ permits a numbered Policy in an adopted development plan to be superseded in full or in part, as long as it is possible to identify what constitutes "the superseded policy".
- 1.3. This Note addresses the Wiltshire Local Plan Pre-Submission Draft 2020-2038 (CD/01) (the Plan) and focuses solely on the issue of policy supersession. Considering the issues raised in the Inspectors' letter of 17 November 2025 (ID11), the council appreciates that further main modifications may arise as the examination progresses and is content to revisit the matters addressed in this Note as necessary in due course.

Approach to the supersession of policies

- 1.4. The Wiltshire Local Plan Review, as reported within the Local Development Scheme (Appendix A of SD/39 and SD/39A²), includes³:
 - targeted updating of existing Wiltshire Core Strategy (WCS) development management policies to ensure their continued consistency with national policy;
 - the introduction of further detailed development management policies as part of a review of the saved development management policies not replaced by the WCS; and
 - developing additional locally distinctive policies to plan positively for all town centres in Wiltshire consistent with national policy.
- 1.5. Reflecting this, the Plan (CD/01) has reviewed, updated and introduced new policies to guide the determination of planning applications and meet Wiltshire's development needs. In many cases this has resulted in policies within the existing development plan being superseded by new policies or deleted. Reflecting the requirement of Regulation 8(5) of the 2012 Regulations, the Plan, at Appendix A, contains a series of tables which set out how policies have been revised as part of the review process, thus intending to outline where the Plan contains a policy that supersedes another policy in the adopted development plan and identifying the superseded policy.

- 1.6. Given the documents within the scope of the Wiltshire Local Plan review include the Wiltshire Core Strategy (WCS, DP/01), alongside saved policies from the former district local plans⁴ that still form part of the overall development plan for the area (as outlined at Appendix D, DP/01), Appendix A to the submitted Plan currently sets out tables that contain the following information:
 - Table A.1: Presents the Plan policies alongside information as to their relationship to WCS policy.
 - Table A.2: Presents policies from the WCS including a summary of their purpose and the outcome of their review.
 - Table A.3: Presents a list of proposed new policies for the Plan that cover development management themes.
 - Tables A.4 to A.8: Present saved policies from the former district local plans including a summary of their purpose and the outcome of their review.
- 1.7. Appendix A of the Plan presents this information in a manner that outlines which policies are new (i.e. not contained within the WCS), alongside the use of terms such as policies to be deleted, updated, combined, retained and replaced.
- 1.8. Given the legislative requirement of Regulation 8(5) of the 2012 Regulations and based upon reflections on the content of what has been submitted, the council acknowledges this information could be presented more clearly and be more directly related to the term 'superseded' (or not superseded or part superseded, as dealt with later within this Note).
- 1.9. Acknowledging this, the council proposes that modifications to the Plan could be made whereby Appendix A is reshaped to provide a clear expression of which policies of the WCS and saved former district local plan policies are to be saved, superseded, part superseded, deleted or part deleted by the policies in the Plan⁵. This information is proposed to be presented as follows:
 - Table A.1 (revised Table A.2): Takes the WCS in plan order and addresses the status of each policy in turn, clearly stating whether a policy is 'superseded', 'part superseded', or 'deleted'.
 - Table A.2 (revised Tables A.4 A.8): Takes the saved policies from the former district local plans and addresses the status of each policy in turn, clearly stating whether a policy is 'saved', 'superseded', 'part superseded', 'deleted', or 'part deleted'.
 - Tables A.1 and A.3 of the Plan as it is currently presented would be deleted in the interests of clarity as they are not applicable to the superseding of policies in the development plan.
- 1.10. A modified version of Appendix A of the Plan is presented at Appendix 1 of this Note. As a result of the proposed modifications to Appendix A, Appendix D of the submitted Plan (CD/01) is no longer necessary and is proposed to be deleted.

The approach to existing site allocations

- 1.11. The Plan, within the policies for Market Towns and Principal Settlements (6, 9, 12, 14, 16, 17, 22, 36, 39, 44, 47, 52, 57, 58 and 60), sets out which site allocations will contribute to meeting the overall level of growth for that place. This includes, for instance, new site allocations within the Plan, site allocations within separate development plan documents⁶ alongside site allocations from policies within the WCS and saved policies from the former district local plans that are yet to be completed and will contribute to meeting development needs.
- 1.12. For those site allocations from policies within the WCS and saved policies from the former district local plans that are yet to be completed⁷, the intention is to retain these allocations. In many instances such allocations fall within wider policies within the existing development plan. Whilst much of what is contained within such policies is intended to be superseded by the Plan, once adopted, information pertaining directly to the site allocations is proposed to be retained. This approach has been taken in the interests of brevity and reflects the matter of principle as set out in EXAM 5 (paragraph 13) that Regulation 8(5) of the 2012 Regulations permits a numbered Policy to be superseded in part, as long as it is possible to identify the part that constitutes the superseded policy. In this regard, the proposed amended Tables A.1 and A.2 (as contained in Appendix 1 to this Note) can clearly identify where and how a numbered Policy is part superseded.
- 1.13. For instance, Core Policy 29 of the WCS (DP/01) outlines that Ashton Park Urban Extension is allocated for 15 ha of employment use and 2,600 dwellings. Policy wording within Core Policy 29, in part, directly relates to how the allocation will come forward, including the need to deliver requirements within the development template set out in Appendix A of the WCS. Using this example, Core Policy 29 will be part superseded, with the part directly relating to Ashton Park Urban Extension retained. Such an approach reflects that undertaken by the Wiltshire Core Strategy within its Appendix D (DP/01), for instance where some allocations within Policy BD1 of the North Wiltshire Local Plan were saved and some not.
- 1.14. To offer further clarity, further to the proposed amendments to Appendix A of the Plan, the council proposes that amendments could be made to the supporting text to the Market Town and Principal Settlement policies. Here, reasoned justification could be added to clarify where strategic allocations from the existing development plan are retained and are anticipated to contribute towards delivering the strategic requirements set for that place through the relevant Area Strategies established in Chapter 4 of the Plan (CD/01).
- 1.15. Appendix 2 to this Note presents these potential modifications to the main body of the Plan, providing suggested tables for insertion into the relevant policies' reasoned justification text that would complement and clarify what is contained within Market Town and Principal Settlement policies with regards existing allocations.

Conclusion

1.16. The council considers the approach outlined in this Note, regarding the supersession of policies in the development plan, to be sound and legally compliant, subject to modifications as proposed. As introduced in paragraph 1.1, whilst proposing modifications in the interest of clarity, the approach taken is reflective of that as per the submitted Plan and it is not considered that there are any consequential matters that require addressing, for instance in relation to sustainability appraisal. Further sustainability appraisal (and any

- other necessary assessments) will nonetheless be carried out as necessary as the examination progresses and proposed main modifications are assessed
- 1.17. The proposed modified version of Appendix A of the Plan is set out at Appendix 1 of this Note and proposed modifications to the main body of the Plan are set out in Appendix 2. A summary of the proposed modifications is provided at Appendix 3 of this Note for clarity including consequential proposed modifications to the main settlement policies to align with the updated supersession tables set out in Appendix 1 of this Note. Such changes reflecting, for instance, the removal of allocations that have been completed and the correction of site allocation titles to ensure consistency and accuracy.
- 1.18. The council look forward to discussing the matters raised in this Note with the Inspectors and others in due course. Should the Inspectors consider a different approach to be appropriate to the supersession of policies in any respect, the council would be content to consider this.

Proposed new Appendix A of the Local Plan Review

Appendix A Schedule of policies superseded

This Appendix presents two tables (A.1 and A.2) which set out how policies have been reviewed as part of the Wiltshire Local Plan Review.

The term "saved" is used in Table A.2 for instances where a former district local plan policy remains in full (i.e. is neither fully nor partially superseded for the purposes of Regulation 8(5) of the 2012 Regulations).

The term "deleted" is used for instances where a policy (or part of a policy) is superseded by the Plan with no replacement policy addressing the issues under the old policy (or part of the policy). The term "superseded" is used where a policy is superseded (in whole or in part) and replaced by new policy.

Table A.1 takes all the existing policies from the Wiltshire Core Strategy in plan order and addresses the status of each policy in turn, clearly stating whether a policy 'superseded', 'part superseded', or 'deleted'.

Table A.2 takes the saved policies from the former district local plans and addresses the status of each policy in turn, clearly stating whether a policy is 'saved', 'superseded', 'part superseded', 'deleted', or 'part deleted'.

- 4. Insertion of the tables, as contained at Appendix 2 of this Note, as reasoned justification within the supporting text for the corresponding main settlement policies of the Plan in locations as appropriate.

The proposed modifications to the Main Settlement policies below are intended to align with the updated supersession tables set out in Appendix 1 of this Note. These updates also include the removal of allocations that have been completed (i.e. built out, as set out in EXAM 6) and the correction of site allocation titles to ensure consistency and accuracy with the references used in the adopted Wiltshire Core Strategy (DP/01) and Wiltshire Housing Site Allocations Plan (DP/02).
