South Worcestershire Development Plan – Further response to EXAM6 – Work programme

Further to the Councils' initial response (EXAM 6A) a work programme is enclosed that sets out how the Councils will seek to meet requirements for the completion and submission of updated and outstanding evidence documents, including a refresh of any evidence documents which may be at risk of having been overtaken by events or was more than two years old on submission of the Plan. The work plan is included at Appendix A. This programme has been agreed with by relevant stakeholders including Worcestershire County Council, and there is also ongoing dialogue with National Highways regarding the Transport Model and a series of meetings are taking place with them.

In addition to Appendix A and as is usual practice, the Councils will also provide an updated housing trajectory and monitoring report, a revised housing topic paper and a five year housing land supply report update for 23/24. This will be provided upon completion of monitoring.
